In the State of Texas the horsemen's bookkeeping system is centralized by the Texas Horsemen's Partnership, in order to better serve the horsemen running at the numerous tracks throughout the state. It is now similar to branch banking.

This means that any necessary account maintenance can be done from any racetrack running a live meet in the state and through the Texas Horsemen's Partnership's main office in Austin year round.

Prior to starting a race an owner must have on deposit with the Horsemen's Bookkeeper the amount required to cover all costs incurred in starting that horse.

Prior to putting in a claim for a horse the owner or their Designated Representative must insure that all funds incurred with claiming a horse are on deposit in said account.

The race office will close approximately 30 minutes after the last race of the weekend.

If you need your foal certificates please be sure and pick them up by that time as the Race Office is **NOT** open during weeks that we do not have entries.

Also note that any Quarter Horse foal certificates left in the race office after the final day of racing will be sent to Lone Star Park and any Thoroughbred foal certificates left in the race office will be sent to Retama Park.

## **TERMS AND CONDITIONS**

The Rules of Racing adopted by the Texas Racing Commission governs all races run at G.C.F.A. Entries to any stakes at G.C.F.A. are received only with the understanding that Management of this Association reserves the right to refuse entry or acceptance to transfer of any entry for any cause and without notice to the subscriber. No nomination or entry will be received except upon agreement of the following conditions: That all disputed claims and objections arising out of the actual running of a race, or with respect to interpretation of the condition of any race shall be decided by the Stewards, or whom they appoint, and that their decision regarding any and all points shall be final.

G.C.F.A. reserves the right to divide a race, including both the added monies and all fees, in the event that there are a greater number of starters than the track can accommodate.

In all stakes, entries must be made through the entry box by the usual time of closing. It is understood and agreed that entries are accepted with the understanding that the horse(s) entered will only be allowed to start if in good standing at the time of the actual running of the race.

**G.C.F.A. reserves the right to cancel any stake at any time prior to the actual running without liability, except for the refund of nomination and entrance fees if any.**

It is hereby agreed that G.C.F.A. shall not be liable for and that the owner(s) and lessee(s) of the horse will indemnify and hold harmless G.C.F.A. and its officers against all responsibility or liability or claim for injury or damage to any other person(s) involved with the entrant caused by the horse or by any other person, whether by negligence or otherwise, on the grounds of G.C.F.A.

The subscriber hereby assigns to G.C.F.A. any and all rights to photographs, motion pictures, television and radio broadcasts in connection with any race run at G.C.F.A.

In Stakes/Handicaps: If you are in the top 10 and do not enter back you will lose your nomination fee. If you scratch after entering back you will forfeit your nomination fee and entry fee. If you are not in the top 10 the nomination will be refunded, unless your weight or earnings would have earned you a spot in the race after entries.

## TIME TRIALS

The ten (10) fastest qualifiers will be selected from the trials to compete in the final. If you choose not to enter the finals you will be paid last place money. In the event that 100 or more horses remain eligible and enter the trials, one consolation heat will be carded. The next ten (10) fastest horses will be selected from the trials to compete in the consolation. If you scratch out of the finals you will be paid last place money.

There will be no also eligible list for the trials or finals except in the case of disqualification for a positive drug test report or ineligibility of a horse according to the conditions of the race. Should a horse be disqualified for a positive drug test report or ineligibility of the horse according to the conditions of the race, the next fastest qualifier shall assume the disqualified horse's position in the final.

In the event that two or more time trial contestants have the same qualifying times and a tie exists; a draw by lot will be conducted to determine eligibility to compete in the trials. (Except in the event that said entrants compete in the same trial heat and no dead heat exists; the horse that finishes in the best position will automatically qualify.)

In the event that the automatic timing device fails during the running of a trial heat, the time of the winner will be determined by official hand timing. Times shall then be assigned to the other entrants based on their relative positions on the photo strip.

If a mechanical failure of the starting gate occurs, or if a horse is inadvertently left behind the gate when the field is dispatched during a trial, such horse shall be declared a non-starter, and all nomination, entry, and starting fees shall be refunded. During a running of a final or consolation, said entrant(s) shall also be considered a non-starter and awarded last place purse money.

In the event any of the ten (10) fastest qualifiers does not enter the final for any reason other than a positive drug test or ineligibility according to the conditions of the race (i.e. age, breed, ringer, etc.) such horse(s) shall receive last place purse money.

## WHEN NOMINATING FOR NON-TRIAL STAKES / HANDICAPS

The nomination **MUST** be received in the G.C.F.A. Office by 5:00 PM of the date the nominations close. If you are mailing in such a nomination please allow ample time for the nomination to be received by the 5:00 PM deadline. If you are having the THP Bookkeeper make a nomination please do it early enough so they too will have time to get it sent to the G.C.F.A. Office by the 5:00 PM deadline

## PURSE DISTRIBUTION

All places shall be paid in overnight races. Sixth through last place shall be paid the following:

Thoroughbred / Arabian \$100

Quarter Horse / Paint \$50

The first through fifth place purses shall be paid as follows after sixth through last place money has been deducted from the total purse:

1st-60 %, 2nd-20%, 3rd-10%, 4th-6%, 5th-4%.

Stakes races and consolations with qualifying trials: 1st-35%, 2nd-15%, 3rd-10%, 4th-8%, 5th-5.6%; 6th-5.5%, 7th-5.4%, 8th-5.3%, 9th-5.1%, 10th-5.1%.

Trial races, non-trial stakes races and handicap races: 1st-60 %, 2nd-20%, 3rd-10%, 4th-6%, 5th-4%.

(a) be approved by a licensed starter for proficiency in the starting gate within 90 days of the race entered; and

(b) have two published workouts, one within 90 days and one within 45 days of the race entered.

\* Horses that have not started within 45 days must have 1 official work within that 45 days, prior to starting.

\* Upon entering the track for a work, you must report to the clocker. You will need to report the name of the horse and the name of the trainer. You must have on file the registration papers or a copy of the papers in order to get an official time for your work.

\* The track will have works immediately following Saturday races. Horses must be saddled and in paddock immediately following last race. Arrangements for works must be made with the race office. **NO** horses will be worked without prior arrangements. **NO** horse will be allowed to work and race on the same day.

\***NO** gallops or exercises will be done. Fees must be paid prior to working horse. **The Track will charge \$10 for ALL works.**

**\*IF YOU WILL NEED A STALL FOR A HORSE THAT IS WORKING YOU MUST CONTACT THE RACE OFFICE AND REQUEST ONE. IN ALL CASES HORSES RACING WILL HAVE PREFERENCE TO STALLS OVER HORSES WORKING BUT EVERY EFFORT WILL BE MADE TO ACCOMMODATE STALLS FOR HORSES THAT ARE WORKING ONLY.**

\*HORSES MUST BE WORKED BY A TXRC LICENSED JOCKEY. NO EXERCISE RIDERS WILL BE ALLOWED TO WORK HORSES. Please make sure you have your Jockey lined up prior to the beginning of the works.

## TRACK RULES

### STABLE AREA

- \* Use of stalls overnight must be approved by the stall superintendent.
- \* Stabling with another trainer must have prior approval by stable superintendent.
- \* Stalls will be available for haul-in use only.
- \* No dogs will be permitted in stable area.
- \* No alcoholic beverages are permitted in stable area.
- \* All horses must be tattooed prior to start.

### HORSEMEN PLEASE NOTE

Jockeys should be named at time of entry. Final naming of riders on open horses must be done by no later than 9:00 AM the day after entry. If you fail to name a jockey by that time, one will be selected by lot.

Trainers must be licensed by the Commission at time of entry, except stakes races, Owners may be licensed up to 1 hour prior to the post of the first race.

A jockey or apprentice jockey may not ride in a race unless the jockey or apprentice wears a safety vest. A safety vest may weigh no more than two pounds and must be designed to provide shock-absorbing protection to the upper body of at least a rating of five.

### CLAIM PROCEDURE

All claims must be made in writing in forms and in envelopes furnished by the Association and approved by the Commission. Both forms and envelopes must be filled out completely, and must be accurate in every detail; otherwise the claim will be void. The determination of what is accurate is within the sole discretion of the Stewards. Notwithstanding any designation of sex or age on the racing program or any racing publication, claimant is solely responsible for determining the age or sex of the horse claimed, prior to depositing the claim form. The prior trainer or his agent must accompany the horse until all samples are taken. **THE CLAIM AMOUNT AND ALL TRANSFER FEES MUST BE ON DEPOSIT WITH THE THP HORSEMEN'S BOOKKEEPER AT THE TIME A CLAIM IS MADE OR CLAIM WILL BE VOIDED.** Anyone making a claim must first apply for an Owner's license from the Texas Racing Commission.

### PREFERENCE DATE SYSTEM --

Horse registration certificates must be on file with the Racing Secretary in order to start. You may enter with a copy but will receive no preference.

Horses with foal certificates and a valid Coggins on file in the racing office will be issued an entry (E) date. Foal certificates that are on file in the office prior to the first day of entries will receive a zero date (E 00/00/00). After that, foal certificates will receive a date corresponding to the date the foal certificates arrive in the racing office during weeks that the racing office is open.

Horses whose foal certificates arrive during weeks that the racing office is not open will receive an entry (E) date for the date prior to the first entry date for the next time the racing office is open.

Horses who start in a race or are scratched from a race will receive a race date (R) date.

(E) Dates have preference over (R) dates. Preference dates will not supersede the conditions of the race. Date preference will not supersede rules regarding preference, eligibility, or scratches.

This date system does not include trial or stakes races. Horses will not lose their preference date in trials or stakes races.

All Owners and/or Trainers making entries must sign entry blanks.

Any Owner and/or Trainers entering two horses into an overnight race must prefer one horse.

Maidens entering against winners must be noted at time of entry, and will receive least consideration.

In all matters of discretion, the Steward's ruling is final.

### EQUIPMENT CHANGES --

If a horse has not started in the current calendar year such horse will establish their equipment (i.e. blinkers on / blinkers off) in their first start at the Gillespie County Fairgrounds. If a horse has started at any racetrack during the current calendar year such horse will be required to race in the equipment (i.e. blinkers on / blinkers off) as it did in that start unless a change of equipment was requested at time of entry.

Though the race office will gladly assist horsemen with finding out what equipment a horse had in their last start, horsemen are solely responsible for knowing what equipment their horses are required to race in.

In all matters of discretion, the Steward's ruling is final.

## **Androgenic-Anabolic Steroid Rule:**

Sec. 319.364. Testing for Androgenic-Anabolic Steroids

(1) No androgenic-anabolic steroids shall be permitted in test sample collected from racing horses except for residues of the major metabolite of stanozolol, nandrolone, and the naturally occurring substances boldenone and testosterone at concentrations less than the indicated thresholds.

(2) Concentrations of these androgenic-anabolic steroids shall not exceed the following urine threshold concentrations for total (i.e., free drug or metabolite and drug or metabolite liberated from its conjugates):

(a) 16 $\beta$ -hydroxystanozolol (metabolite of stanozolol (Winstrol)) - 1 ng/ml in urine for all horses regardless of sex;

(b) Boldenone (Equipoise® is the undeclyenate ester of boldenone) in male horses other than geldings - 15 ng/ml in urine. No boldenone shall be permitted in geldings or female horses.

(c) Nandrolone (Durabolin® is the phenylpropionate ester and Deca-Durabolin® is the decanoate ester)

(A) In geldings - 1 ng/ml in urine

(B) In fillies and mares - 1 ng/ml in urine

(d) Testosterone

(A) In geldings - 20 ng/ml in urine

(B) In fillies and mares - 55 ng/ml in urine

(3) Any other anabolic steroids are prohibited in racing horses.

(4) Post-race urine samples must have the sex of the horse identified to the laboratory.

(5) Any horse to which an anabolic steroid has been administered in order to assist in the recovery from an illness or injury may be placed on the veterinarian's list in order to monitor the concentration of the drug or metabolite in urine. After the concentration has fallen below the designated threshold for the administered androgenic-anabolic steroids, the horse is eligible to be removed from the list.

## **ATTENTION HORSEMEN ENTRANCE REQUIREMENTS**

## **ENTRANCE TO GILLESPIE COUNTY FAIR GROUNDS STABLE AREA EFFECTIVE 2011 MEET**

### **ALL HORSES ENTERING THE STABLE AREA OF GCFA MUST BE ACCOMPANIED BY:**

A Certificate of Veterinary Inspection (health certificate) dated no more than forty five (45) days prior to entrance to GCFA stable area. The Certificate of Inspection must include evidence of a negative EIA (Coggins) test within the past twelve (12) months.

**AND**

**A negative Piroplasmosis cElisa test for Theileria equi and Babesia caballi that has been performed in the last year will now be mandatory.**

### **Toe Grabs Rule:**

Sec. 313.426. Toe Grabs Prohibited

(a) A Thoroughbred or Arabian horse is ineligible to start in a race when it has shoes (racing plates) that have toe grabs with a height greater than two millimeters (0.07874 inches), bends, jar calks, stickers, or any other traction device on the front hooves.

(b) A Quarter Horse, Paint Horse, or Appaloosa is ineligible to start in a race when it has shoes (racing plates) that have toe grabs with a height greater than four millimeters (0.15748 inches), bends, jar calks, stickers, or any other traction device on the front hooves.

TXRC LICENSING OFFICE NOTICE:

The Texas Family Code, Chapter 232, prohibits state agencies from renewing a license if the Office of the Attorney General (OAG) has notified the agency that the licensee is in default on child support.
